Good morning,

I've unfortunately been unable to time my calls to you at a convenient moment, so I wonder if it's possible to set a telephone meeting time that works for you? I'm aware that you must be very busy, and I hope that it won't take too long.

Just for context – for the 2013 election, we had general agreement from the Department that we could contact each of the prisons and arrange voting services for the inmates. When we did this, the prisons were clear that their preference was not to have the AEC attend, but to provide information, including enrolment and postal voting services, through a single point in each prison. At this stage we are just looking to establish what the preferred approach is for each of your facilities. We are more than happy to deliver face to face services, however we are aware that this isn't always operationally possible, so we want to make sure we arrange alternate voting arrangements for those who are eligible.
