FINANCIAL YEAR 2022-23

- This return will be available for public inspection from 1 February 2024 at www.aec.gov.au.
- Any supporting documentation included with this return may be treated as part of a public disclosure and displayed on the AEC website.
- The information on this return is collected under s 305B and s 306 of the Electoral Act.
