In accordance with section 68(1)(c) and 68(1)(d) of the *Commonwealth Electoral Act 1918* (Electoral Act), notices were published in the *Commonwealth Government Notices Gazette* on Friday 16 October 2015 and will be published in:

- *The Sydney Morning Herald*, *The Daily Telegraph* and *The Weekend Australian* on Saturday 17 October 2015, and
- *The Land* on Thursday 22 October 2015

inviting interested individuals and organisations to make written objections against the proposed redistribution and comments on the objections. Notices may also be published in selected regional newspapers.

In accordance with the requirements of the Electoral Act, written objections must be lodged by 6pm Australian Eastern Daylight Time (AEDT) on Friday 13 November 2015 to allow them to be considered. All objections received by the lodgement time will be published on the AEC's website, [www.aec.gov.au](http://www.aec.gov.au) from Monday 16 November 2015. Comments on objections are able to be lodged until 6pm (AEDT) on Friday 27 November 2015 and will also be published on the AEC website from Monday 30 November 2015.

After considering the written objections and comments on objections, the augmented Electoral Commission for New South Wales will make a proposed redistribution of New South Wales and will make a public announcement about this proposal. The augmented Electoral Commission will make a final determination of boundaries and names of the electoral divisions for New South Wales by notice published in the *Commonwealth Government Notices Gazette* on 25 February 2016.

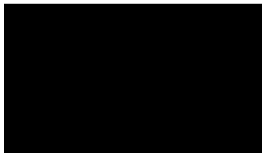
