### Polling services for Prisons in Tasmania – Federal Election 2016

As you may be aware we are currently planning for the Federal Election that is due to occur in 2016. We are reviewing the arrangements that we had in place for the 2013 Federal Election and following discussions with your staff would like to confirm that there will be no mobile polling in any Prison Service establishment for the 2016 Federal Election. This is mainly due to circumstances relating to security (s.227 (6A) the Electoral Act).

It has been agreed that the Australian Electoral Commission will provide Postal Vote Applications for prisoner use at the election and these applications are also available on-line at [www.aec.gov.au](http://www.aec.gov.au).

I have attached an information sheet that describes the process for enrolling as a prisoner and attached an application form. These are also available from our website.

Once the election is announced, The Australia Electoral Officer and State Manager for Tasmania will provide an election timetable to you, for your information.
