Thank you for your consideration of Council's earlier submission – dated 16 November 2017 - and the subsequent recent release of the proposed changes to the Commonwealth electorates covering Maroondah City Council.

Council wishes to submit a comment as an objection to the proposed redistribution. Council appreciates the proposed changes go a long way to responding positively to Council's request to be covered as much as possible by one electorate based on communities of interest.


We do believe, however, that a further minor change has merit and meet the voter population tolerances required for Deakin. Council supports the view contained in its earlier submission and the view of Yarra Ranges Council for:

- (1) the locality of Kilsyth in the Yarra Ranges LGA to be retained in the Casey electorate (6,979 voters); and
- (2) the transfer of the locality of Warranwood in the Maroondah LGA to the Deakin electorate (3,576 voters).

Council believes that the communities of interest of both municipalities would be better served with the further changes suggested.
