Subject: Objection to the Proposed Abolition of the Federal Electoral Seat of Higgins

Dear Australian Electoral Commission,

My name is Marcel Kreis, and I am writing to you from [REDACTED] Toorak, with a deep sense of urgency and concern regarding the proposed abolition of the federal electoral seat of Higgins in Melbourne. As a resident of Stonnington, I feel compelled to voice my strong objection to this proposal, which I believe will have far-reaching negative consequences for our community.
